If you have unwanted medication and aren't sure how to dispose of them, there is a medication dropbox located in the City office. Medications can be in their original containers or in plastic bags if they are loose. Please make sure any liquid medication is in a secure container and the container then placed in a plastic bag. Needles can also be disposed in the needle drop box at the City office.

The officer on duty will return your call as soon as possible.

## Free Burn Weekend in The Spring

In the spring of 2020, the City will be holding a burn weekend. During the burn weekend, residents will not need to purchase a burn permit and are encouraged to burn their brush and remaining leaves at this time. The dates have not yet been set. ## Cleanup Week

Tentative dates for a 30-yard dumpster are May 18th thru May 21st, 2020. City residents may unload "non-hazardous" household waste into the dumpster at no charge. More information will be available in the next newsletter.

#### **Snow Removal on Sidewalks**

Ordinance #53 section 302.3- Requires property all owners to keep sidewalks adjacent to their property free from anything that will obstruct them or cause a hazard to public safety. So please be mindful and **keep your sidewalk clear of snow and ice**. Winter can be a difficult time to get around for those on foot. Per City Policy, the DPW will clear sidewalks during single snow events of 10 or more inches of accumulation or as time permits during a regular work day.

#### **DPW Staff**

The City DPW works as quickly as possible during inclement weather to assure the safety and clearance of all city streets for the use of emergency vehicles and citizens. Your patience, cooperation, and understanding will help the road crews to clear the roads faster and safer.

#### **Snow Plow Permits**

The City requires that snow plow permits be obtained for snow plowing within the City limits. Permits are \$10 and are available at the City Office. It is important to note that if you are plowing your own driveway or a family member's driveway, you do not need a permit. If you are a property owner hiring a plow company, please direct them to the City Office for a permit.

## Winter Parking Restrictions-Ord. #18

The City reminds residents/businesses/visitors that there is no parking of any motor vehicle upon any public street or alley within the City limits between the hours of 2am and 6am November 15-April 15. This aids City plows removing snow from streets. Signs are posted around the City that also serves as a notice. If your vehicle is towed, signs have the appropriate contact number to call.

#### **How Do I Handle Sewer Issues?**

If you experience slow drains or notice drains bubbling up, first call the City DPW at 834-7462. City staff will check the main line from the manhole to determine if it is obstructed. If the main line is obstructed the City will clear the line and is responsible for any property damage. If the main is flowing, then it is likely you have roots or grease buildup in your lateral or have an old clay lateral that may have collapsed. If it is determined that the issue is your lateral, you should call a plumber immediately. You are responsible for your sewer lateral to the main line, just like you are responsible for your driveway to the street.

# Water Freezes at 32 Degrees!

Each winter the DPW responds to properties that are not adequately insulated or heated, which in turn can result in pipes/meters bursting and a high bill. Remember it is colder near the floor and along the block wall of a basement than at the ceiling, so make sure warm air is allowed to circulate around your meter. Please make sure that there is adequate insulation, heat or appropriate winterization to avoid costly repairs.




The 2020 Census counts every person living in the United States and the five U.S. territories. The count is mandated by the Constitution and conducted by the U.S. Census Bureau, a nonpartisan government agency. Each home will receive an invitation to respond to a short questionnaire-online, by phone, or by mail. This will mark the first time that you will be able to respond to the census online. This will begin on March 1, 2020.



# **Snow Plowing Across the Road**

The 2nd picture shows trails of snow left on the pavement after it was illegally plowed across the road. This snow is what presents a serious traffic hazard for those driving on the road as it creates unnecessary drifts and ice ridges on the pavement. As temperatures change, the area can become ice which causes cars to slide. The Grant Police Department will issue citations to anyone caught plowing or blowing snow across city roads. If you have someone plowing/blowing your driveway, please make sure they are not adding to the hazards of wintertime driving. Let them know that if they are plowing/blowing snow across the road and are caught, this will result in a \$100 ordinance ticket.



# Winter Snow Plowing: Understanding Plowing Near Driveways

Driveways are always a sensitive issue when it comes to snow removal. DPW crews are aware of this problem, however, there is no practical way to plow snow without depositing snow into driveways. Drivers will do their best to minimize filling in or blocking driveways. The graphic to the left shows how a driveway can be initially cleared to reduce the likelihood of the plow filling the entrance. If you shovel or move the snow in the direction of traffic, making a pocket next to the driveway as shown, snow accumulation on the plow will drop into that pocket and only a bare minimum will go into the opening.

# **Winter Taxes**

Winter property tax bills were available December 1st and are due by Friday, February 14th, 2020. The City will accept late summer and winter tax bills with penalties until Fri, February 28, 2020. After this date delinquent taxes go to the County and payments must be made to: Newaygo County Treasurer's Office, P.O. Box 885, White Cloud, MI 49349. ## Water/Sewer Billing Schedule for 2020

Water and sewer is billed out quarterly. Payments can be made throughout the quarterly billing cycle (weekly, biweekly, monthly) to reduce the amount owed at the end of the quarter. Payments can be made using cash, check, money order or credit card. The billing dates for the 2020 calendar year are as follows:
